This involvement, as well as the use of Articles 42 to 46 of the Common Security and Defence Policy (CSPD) of the Treaty on European Union are likely to further increase in the upcoming years.

The project contributes to this agenda as laid out by the European Commission's Horizon 2020 strategy. PeaceTraining.eu was developed as a coordination and support action, in the context of the CPPB: Training curricula for CPPB personnel call and it brings together 12 partner organizations from 8 different countries.

### PROJECT FACTS

The Consortium will review and analyse the state-of-the-art and approaches to training on conflict prevention and peace-building. Based on this analysis, the Consortium will develop recommendations of good practices and lessons learned on training curricula and methods in the field of military, police and civilian CPPB.

PeaceTraining.eu will aggregate a comprehensive collection of current training providers, training programmes. approaches in conflict prevention and peace-building in Europe and of the EU. Over the period of two years (2016-2018), the project aims to explore and analyse good practices, efforts and training needs of European actors. The goal is to map out and connect stakeholders, to provide recommendations on best practices as well as innovative information and communication technology (ICT) approaches to training

This analysis will determine the present gaps in current training practices and will elaborate scalable curricula recommendations to be applied in various types of trainings all over the world.

From this, a web platform, including a comprehensive knowledge base will be created. This platform aims to connect the existing CPPB training community in Europe and beyond, as well as bring a valuable resource for those new to the field, for instance through a Training Organisation Search Tool. This shall support the development of a pan-European community of CPPB actors and a harmonization of the approaches to training.
